## Transfer of all Class XIII employers to RMA

The Government Gazettes, Nos. 37826 and 38044, released by the Department of Labour served to inform all employers who fall within Class XIII of the transfer to Rand Mutual Assurance (RMA) in terms of section 30 of the Compensation for Occupational Diseases and Injuries Act (COIDA) from 1 March 2015.

The gazette informs all Class XIII employers as follows:

- That all current Class XIII employers shall continue to be covered by the fund and these employers will pay their 2014 assessment premiums to the Compensation Fund;
- 2. That after 28 February 2015, all Class XIII employers will be transferred to RMA. RMA will collect all premiums and pay all claims.

#### Why is the transfer taking place?

The Department of Labour (Compensation Fund) is in the process of implementing a turnaround strategy to improve its level of service to its members and the transfer is an important component of this strategy. The Compensation Fund remains responsible for overseeing the compliance of RMA regarding all the requirements of the COID Act.
